<sup>3</sup> An item is determined by UES staff and may include additional model series, property method, performance characteristic or assembly which would require separate evaluation to determine code compliance. Often thought of as, an aspect of the product which would otherwise require the issuance of a separate report. Engineering Hours in excess of 4 hours are charged \$275 each.

<sup>4</sup> Only charged if you used UES as your inspection agency. If you already have a relationship with an ISO/IEC 17020 certified agency you may continue to use them.

<sup>5</sup> Travel and other expenses may be charged later.

<sup>6</sup> Fee for new report or annual report renewal.

<sup>7</sup> An inspection report review fee of \$525 is charged per location.
